COUNT ONE:

The Plaintiff claims of the Defendant One Thousand Three Hundred Two and 30/100 Dollars (\$1,302.30) due by Promissory Note made by it on the 1st day of September, 1947, and payable on the 18th day of November, 1948, with interest thereon at the rate of five percent (5%) from the 20th day of December, 1949, which sum of money is still unpaid.

The Plaintiff avers that in, by and as a part of said note the Defendant agreed to pay all costs of collecting, or securing or attempting to collect or secure said note, including a reasonable attorney's fee, whether the same be collected or secured by suit or otherwise and the Plaintiff further claims of the Defendant the further and additional sum of Two Hundred and Fifty Dollars (\$250.00) as such reasonable attorney's fee.

The Plaintiff further avers that in, by and as a part of said note the Defendant waived as to this debt or any renewal thereof, all rights to exemption under the Constitution and Laws of Alabama as to personal property and of this waiver, the Plaintiff now claims the benefit.
