This was not a small loan under the statutes of Alabama, because it exceeded THREE HUNDRED (\$300.00) DOLLARS. Also, the loan was secured by a chattel mortgage on one 1948 Chevrolet 1 1/2 ton truck Dual wheels with two (2) speed rear axle and Brownlight transmission, Tandem Dual rear extra and steel bulb rack, motor number FEA 569641, which the Defendant is unable to produce after being called upon to deliver the truck securing the debt.


FOREST A. CHRISTIAN, first being duly sworn, deposes and says as follows:
