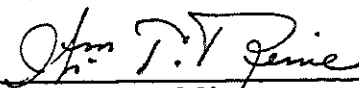

Said sum of \$263.24 is due and payable and there are no counter claims or set offs against said account.

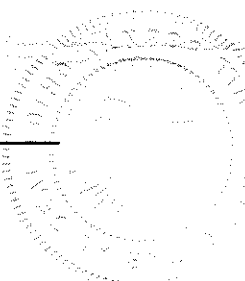
