COUNT ONE

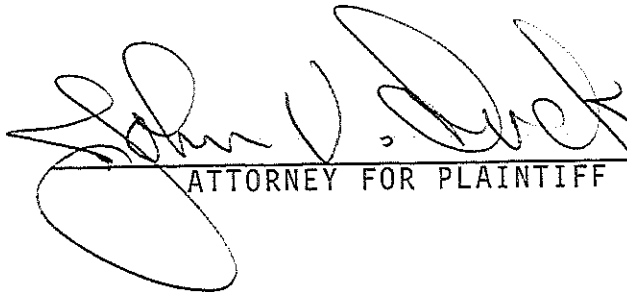

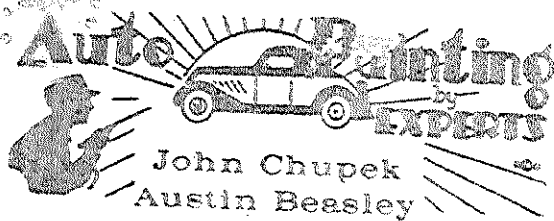
