The condition of the above obligation is such, that, whereas, the above bounden Airon Bodiford

was, on the 11th day of Feb, 1953, convicted in the Municipal Court of said Town of Foley, of the offense of A.D.C., and by the judgment of said Court sentenced to the payment of a fine of \$108.50 dollars.

And, whereas, the said Airon Bodiford has this day prayed an appeal from said judgment to the Circuit Court of said County.

Now, if the said Airon Bodiford shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void; otherwise to remain in full force and effect; and each of us to waive our exemptions as to personal property.
