PETITION FOR WRIT OF HABEAS CORPUS


The Petition of Robert G. Pettry shows:

1. Your Petitioner is illegally restrained of his liberty by being confined in the jail of the said County.

2. The person restraining the liberty of the said Robert G. Pettry is Taylor Wilkins, the Sheriff of said County, and the place of detention is at the jail of said County. The cause or pretense of said restraint by the said Taylor Wilkins is a warrant of arrest on a charge of illegal sale of narcotics, a copy of such warrant being annexed to the petition.

3. Petitioner further avers that he is detained by the said Taylor Wilkins as aforesaid, and now offers to give bail in the sum of \$500.00 which is a reasonable and sufficient sum in a case of the character pending against the petitioner and in keeping with Petitioner's status and tender age of 17 years.


Wherefore, Petitioner avers that his further restraint is illegal and prays Your Honor to issue the State's writ of Habeas Corpus directed to the said Taylor Wilkins, Sheriff, as aforesaid, requiring him to bring Your Petitioner before Your Honor, at the time and place to be specified in the writ, for the purpose of examination into the case of the detention.
