Wherefore, Petitioner avers that his further restraint is illegal and prays Your Honor to issue the State's writ of Habeas Corpus directed to the said Taylor Wilkins, Sheriff, as aforesaid, requiring him to bring Your Petitioner before Your Honor, at the time and place to be specified in the writ, for the purpose of examination into the case of the detention.
