The Plaintiff claims of the defendant the sum of Five Hundred Seventy-Seven and 08/100 (\$577.08) Dollars being the balance due and unpaid of a promissory waive note in the amount of Five Hundred Ninety-Five and 20/100 (\$595.20) Dollars drawn by the defendants on the 17th day of December, 1966, payable to Electronic Products at the Baldwin County Bank, Bay Minette, in 24 installments of \$24.80 each, the first installment being due the 25th day of January, 1967, and the 25th day of each month thereafter until fully paid; with total unpaid amount becoming due on the failure of defendants to pay any of the individual payments, and the said payments not being paid as they mature, by the said defendants, said note was charged back to the account of the plaintiff herein by the Baldwin County Bank of Bay Minette and is owned by the said plaintiff.
