BILL OF COMPLAINT



Plaintiff claims of the Defendant ONE THOUSAND SIX HUNDRED
FORTY-FIVE and NO/100 DOLLARS (\$1,645.00), due by promissory note,
made by Defendant on October 30, 1965, and payable October 30,
1966.

Plaintiff further avers that in and by the terms of said note,
the Defendant agreed to pay interest at the rate of Eight (8%)
percent per annum from October 30, 1965, and Plaintiff claims of
