



The Secretary stated to the Commissioners that the purpose of the meeting was to execute the Contract for Architectural Services with the firm of Dietz, Prince & Fischrupp Architects. He stated that this contract would provide free architectural service to families whose homes are scheduled for rehabilitation and that it was authorized and funded by the NDP Application. You are further commissioned and directed, by these presents, to assess the damages and compensation to which the owners are entitled by reason of the taking and condemnation of said land as set forth in said Petition, and you may view the lands, and must receive all legal evidence offered by any parties touching the amount of damages the said owner will sustain, the amount of compensation to be awarded to the said owner, in fixing the amount to be awarded the owner for lands taken for this use.

You are further directed, within twenty days from the date of this Commission, to make and file in this Court a report, in writing, of the amount of damages and compensation ascertained and assessed by you for the said owner of said tracts of land.
