The proceeding in this cause should not be allowed to proceed and the cause should be abated for the following separate and several reasons:

- 1. The person to whom the writ in this case is directed has not been served with process.
- 2. The person to whom the writ in this case is directed has not been properly and legally served with a copy of said petition.
- 3. A copy of the petition in this case was not served upon the person to whom the writ is directed by a deputy sheriff of this County or by the Coroner of this County, as required by law.
- 4. The writ in this case has not been properly served on the one
- 5. The writ in this case has not been served by a deputy sheriff or coroner of this County upon the one to whom the writ is directed.
- 6. The writ in this case has not been properly served on any person.
- 7. The writ in this case was handed to a deputy sheriff of this County by the attorney for the petitioner, contrary to the previsions of law provided in such cases.
- 8. There being no proper service in this case, your Honor does not have jurisdiction to proceed with a hearing on this cause.

ORDER

Owen, for and on behalf of Clifford McLellan, alias Clifford McLellan, for a writ of habeas corpus, and upon the return of Taylor Wilkins, as Sheriff of Baldwin County, Alabama, and the said Clifford McLellan, alias Clifford McLellon, being present in his own proper person and by counsel, and the State being represented by the Hon. William R. Lauten, Solicitor of the Twenty-eighth Judicial Circuit of Alabama, the undersigned judge proceeds to hear the matter; and after hearing the same the undersigned judge being of the opinion that the said Clifford McLellon, alias Clifford McLellan, is not bunlawfully or illegally restrained of his liberty, it is considered,

ORDERED AND ADJUDGED that the said Clifford McLellan, alias Clifford McLellon, is not entitled to his discharge on habeas corpus, that the writt be discharged and that the said Clifford McLellan, alias Clifford McLellon, be remanded to the custody of Taylor Wilkins, Sheriff of Badwin County, Alabama, to be turned over by him to Ed Blackburn, Jr., Sheriff of Hillsborough County, Florida, for delivery to said Hillsborough County, Florida, for prosecution there, and the extradition is hereby granted.

IT IS FURTHER ORDERED AND ADJUDGED that the costs in this proceeding be and the same are hereby taxed against the said Clifford McLellan, alias Clifford McLellon, for which let execution issue.

TO HONORABLE H. M. HALL, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA:

Your Petitioner, James R. Owen, on behalf of Clifford McLellan, respectfully shows unto the Court and your Honor as follows:

- l. That the said Clifford McLellas is now illegally restrained of his liberty and is imprisoned in the county jail of Baldwin County, Alabama, at Bay Minette, Alabama, by Taylor Wilkins the Sheriff of said County, the said Taylor Wilkins, as Sheriff of said County restrains the said Clifford McLellan under a warrant issued on June 15, 1953, by T. C. Hand, a Justice of the Peace.
- 2. Your Petitioner respectfully shows unto your Honor that the said Clifford McLellan is illegally restrained of his liberty for the following reasons:
 - (1) The warrant under which he is restrained does not charge him with a crime.
 - (2) The warrant under which he is restrained was issued illegally.
- 3. Your Petitioner further shows that by reason of the ing said warrant not charge the said Clifford McLellan with a crime and being illegally issued, he is being illegally restrained of his liberty, that he is being illegally imprisoned and that his said detention is unlawful.
