## COMPLAINT

The Plaintiff claims of the Defendants the sum of Six Hundred Twelve and 50/100 (\$612.50) for work and labor done by the Plaintiff at the request of T. A. MCKENZIE individually and as agent for MARGARET MCKENZIE, on improvements on the following described property, viz:

Farm Numbered 43 Southland Farms, which is also described as the South half of the Southwest Quarter of Section Eleven (11), Township Seven (7) South, Range Two (2) East, except for fourteen (14) acres off the Southeast corner which was deeded to William Moore and wife, containing sixty-six (66) acres, more or less.

which said indebtedness accrued on to-wit, the 26th day of January, 1953, and is now due and unpaid.

The Plaintiff alleges that the above described property is the property of the Defendants, T. A. McKenzie and Margaret McKenzie; that said work or labor was done or performed on improving said land under and by virtue of a contract with the said T. A. McKenzie individually and as agent for Margaret McKenzie, the owners or proprietors thereof; that within six months after the said indebtedness had matured, on, to-wit, the 26th day of July, 1953, Plaintiff did file in the office of the Judge of Probate of the County wherein said land is situated, a verified statement as required by law, a copy of which is attached hereto, made a part hereof, and marked Exhibit "A";

WHEREFORE Plaintiff claims a lien for said amount upon said land and buildings and improvements situated thereon.
