

The plaintiff alleges that his said damages to his said automobile truck were proximately caused by the negligence of the defendant, in that he negligently caused, allowed or permitted said automobile to run upon, over or against the automobile truck of the plaintiff, and as a proximate consequence thereof, the plaintiff's automobile truck was damaged and injured as aforesaid.


