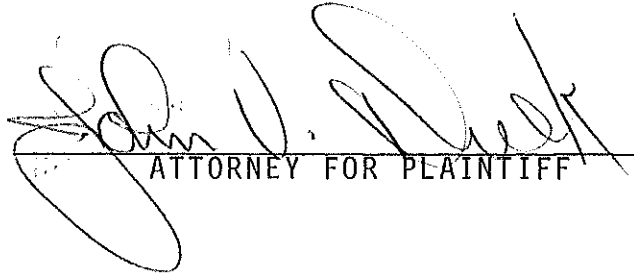
COUNT TWO
