

The Plaintiffs claim of the Defendant, FIVE HUNDRED DOLLARS (\$500.00) damages for breach of an implied warranty in this: the Defendant was engaged in the manufacture and sale of refrigerators during the year 1968, and on, to-wit, November 21, 1968, the Plaintiffs herein purchased from Dorsey Heating & Air Conditioning Company, Fairhope, Alabama, a refrigerator manufactured and sold by the Defendant, being Westinghouse Model RJH65RA0, Serial No. RH317624; that the Defendant in the manufacture and sale of said refrigerator, impliedly warranted that said refrigerator was fit for the ordinary purposes for which such goods are used. Plaintiffs further allege that they are natural persons who could reasonably be expected to use said goods and did rely upon such warranty in the purchase of the aforementioned refrigerator manufactured and sold by the Defendant, and that Defendant breached said implied warranty in that said refrigerator was not fit for the ordinary purposes for which used in that it contained defective evaporator coils, compressor, defroster switch, mullion heaters, top freezer door and defective ice maker, all to the damage of the Plaintiffs, hence this suit.
