



The Plaintiff claims of the Defendant the sum of FIVE THOUSAND DOLLARS for that on to-wit the 15th day of April, 1970 Defendant so negligently operated an automobile on the parking lot

of Spanish Fort Shopping Center in Spanish Fort Community, Baldwin County, Alabama as to cause or allow it to run over against or into the automobile in which Plaintiff's wife, Marge Hunt, was then and there occupying, as a passenger, and that as a proximate consequence of such negligence, Plaintiff's said wife was injured in that her neck, back, shoulders and muscles were injured, twisted and bruised, causing her great pain and anguish, stiffness and soreness so that Plaintiff was deprived of the company and pleasure of his wife's company and consortium, all to his damage, ad quod damnum.
