As I recall this case was filed about August 31 and served the third of October. We have discussed by telephone and reached an agreement as follows: With the Court's permission we will hold this case in obedience until further notice which would not be later than first of March. This is to permit the defendant, Hugh Weeks, to harvest his soy bean crop which is in progress, but due to rainy weather, wet fields, dew, etc., harvest is slow. Since Mr. Weeks has full drying equipment and bins worth many thousands of dollars, he wishes to use this equipment to full advantage as he has in the past.

He usually sells the beans sometime in February.

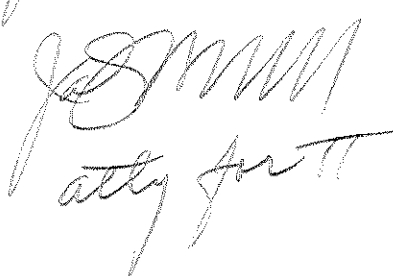
You may approve of this agreement by signing this letter at the end and the original will be attached to the docket sheet for the Courts information.

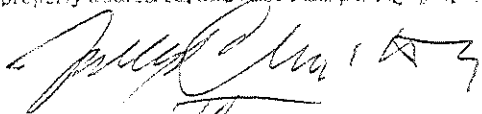
ANSWER OF GENERAL DENIAL
