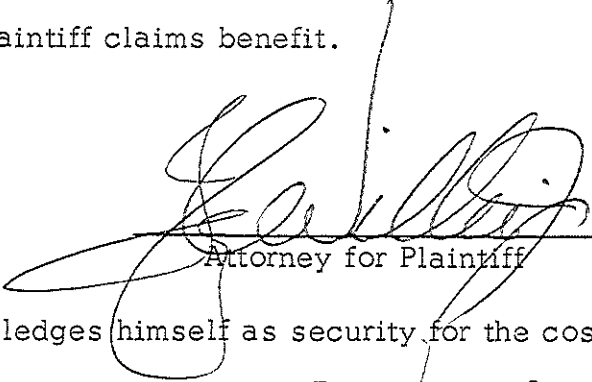
and payable January 10, 1971, with interest thereon.

COUNT V.

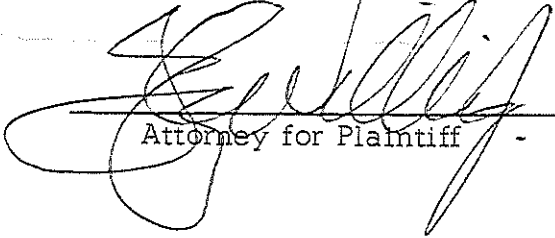
