



The Plaintiff claims of the Defendant THREE HUNDRED AND NO/100 (\$300.00) DOLLARS, as damages, for that heretofore and on, to-wit, the 18th day of July, 1970, the Plaintiff was driving his automobile at a place where it had a right to be, to-wit, on U. S.
