SETTLEMENT AND PETITION

The undersigned, being the only parties in the above entitled cause, hereby petition the Court for approval of the following agreement and settlement, and agree and represent unto the Court as follows:

1. That the parties herein are subject to the provisions of the Work-men's Compensation Law of Alabama. That the said employee, age 31, residing in Bon Secour, Alabama, who can read and understand the English language, did on the 6th day of January, 1970, sustain an injury by accident while employed by said employer, which injury occurred in Bon Secour, Alabama, and resulted in permanent partial disability of said employee, and consisted of ten per cent (10%) of the body as a whole.

Wherefore, it is hereby agreed that the employee is entitled to and shall receive compensation for said injury for three hundred (300) weeks at FOUR AND 64/100 (\$4.64) DOLLARS or a total of ONE THOUSAND THREE HUNDRED NINETY-TWO (\$1,392.00) DOLLARS, less 47 and 5/7 weeks already paid in the amount of TWO HUNDRED TWENTY-ONE AND 38/100 (\$221.38) DOLLARS less overpayment of TTD for a period from the 6th day of November, 1970 through the 23rd day of December, 1970 in the amount of TWO HUNDRED NINETY-TWO AND 53/100 (\$292.53) DOLLARS, the receipt of which is hereby acknowledged by the employee, and the balance of SEVEN HUNDRED THIRTY-FOUR AND 25/100 (\$734.25) DOLLARS, which is the commuted value in the lump sum settlement discounted at 4% for a lump sum settlement, under the statute in such cases made and provided, and is the combined total of compensation commuted to be paid, all subject to the limitations of said act, and the employee agrees to give proper receipts for each payment made hereunder.

The employee acknowledges that he has received to date medical and surgical treatments and benefits given by said Act in the amount of FIVE HUN-DRED SIXTY-FIVE AND 62/100 (\$565.62) DOLLARS, and the employer agrees to continue to furnish the same, if any be necessary to the extent and in the manner required by said Act.

The employee agrees to present himself for examination, or if physically unable to do so, to submit to examination by the physician or physicians designated by the employer when requested.

This settlement contains the entire agreement between the parties hereto.
