COUNT I.

Plaintiff claims of the Defendant the sum of Two Thousand, Three Hundred, Twenty-Nine Dollars and fifty-eight cents (\$2,329.58), due by promissory note made by the Defendant on the 22nd day of January, 1970, and payable on the first day of July, 1970, which sum of money, with interest thereon is due and payable.

Plaintiff alleges that as a part of said promissory note, the Defendant waived all of his right of exemptions under the laws of the State of Alabama and the United States.

Plaintiff further alleges that as a part of said promissory note, the Defendant agreed to pay a reasonable Attorney's fee and that such a reasonable fee is Five Hundred Dollars (\$500.00).

COUNT II.

The Plaintiff claims of the Defendant the sum of \$5,953.28 due by account stated, between the Defendant and Plaintiff from May 23, 1969, to June 23, 1971, which sum of money together with interest thereon, is due and unpaid.

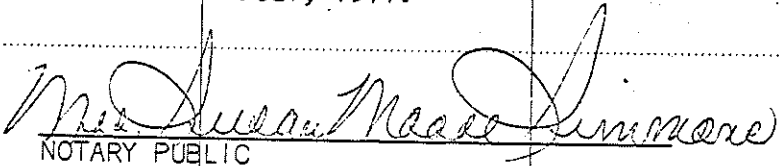
