

The Plaintiff claims of the Defendants the sum of ONE THOUSAND TWO HUNDRED FOURTEEN AND 37/100 DOLLARS (\$1,214.37), the balance due by Promissory Note made by the Defendants on February 21, 1968, and payable in installments, commencing on April 1, 1968, with interest thereon from date of January 1, 1969, at the rate of eight percent (8%) per annum; Plaintiff further alleges that in and by the terms of said note the failure to pay any installment accelerated the balance due under said note and that said Defendants defaulted in their obligation to pay the installments as set out hereinabove.

Plaintiff further alleges that in and by the terms of said note, the Defendants waived all right of homestead under the Laws of the State of Alabama, and Plaintiff claims the benefit of said waiver.

Plaintiff further alleges that in and by the terms of said note the Defendants agreed to pay all costs of collection, including a reasonable attorney's fee, and Plaintiff claims the further and additional benefit of such reasonable attorney's fee in the premises.
