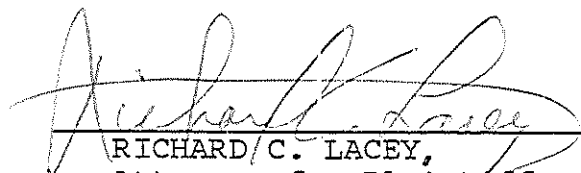
BILL OF COMPLAINT

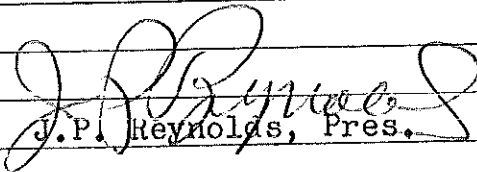
