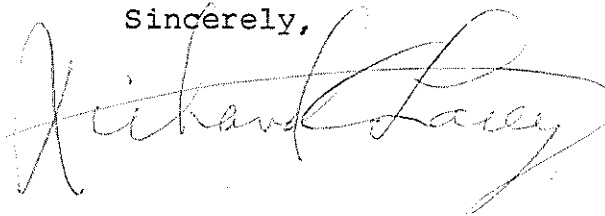

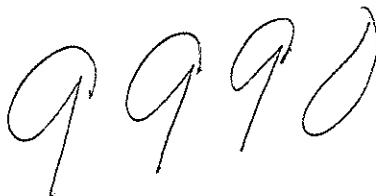

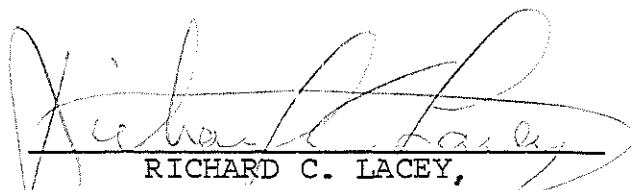
BILL OF COMPLAINT

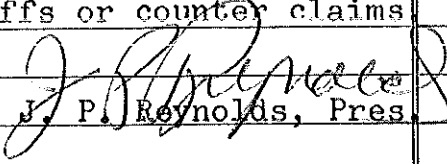
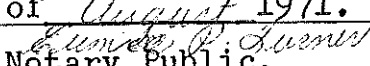
