Your petitioners, London Wyatt, fr., Ellen Mack, Sallie Thomas, Mary Sanders, Ben July, Fannie O. July and Benjamin F. July by his next friend Ben July, respectfully represents and shows unto your Honor as follows:

I. That London Wyatt, Jr., Ellen Mack, Sallie Thomas, Mary Sanders, Ben July and Fannie O. July are residents of Baldwin County, Alabama, residing at Blackshear, and over the age of twenty-one years; that Benjamin F. July is a minor 13 years of age and reside at Blackshear, Baldwin County, Ala.

That Sipp Wyatt, C. G. Wyatt, Mamie Wadkins and Ida Wyatt are over the age of twenty-one yeers and reside at Blackshear, Baldwin County, Alabama--all residents of Baldwin County, Alabama.

2. That your petitioners and defendants are joint owners or tenants in common of the following described property situated, lying and being in Baldwin County, Alabama, to-wit:

The East half of Northwest quarter, Section Four Township Three North, Range Three East, containing in the aggregate ninety acres more or less.

That Your Honor will order a reference held directing the register of this court to ascertain what will be a reasonable solicitors fee to be paid to the Complainants solicitors for services rendered in this proceedings, and to tax such as a part of the cost hereof, and that your Honor will grant such other, further, different and general relief as Complainants may in justice and equity be entitled, etc.

Comes the defendants Sipp Wyatt and C.G.Wyatt and answering the bill of complaint filed in this cause by London Wyatt, Jr., et al., and says:

- 1. They admit that the allegations as alledged in the first paragraph of said bill of complaint are true.
- 2. Answering the second paragraph of the bill respondents Sipp Wyatt and C.G. Wyatt allege that they each own more than a one-fifth interest in the land described in the bill of complaint, and that Mamie Watkins owns more than a onefifth interest therein, but denies that the respondent Ida Wyatt owns a one-fifth interest in said land. Respondents Sipp Wyatt and C.G. Wyatt aver and allege and shows to the court that they each like on a portion of said land and have been residing thereon for more than twenty-five years and each have erected valuable improvements on that portion of the land on which they are now living and have been for the said period of twenty-five years, and that these respondents Sipp Wyatt and C.G. Wyatt aver that the land described in said bill of complaint was owned by their father, Soloman Wyatt, at the time of his death and that all/the parties to the bill of complaint filed in this cause, except Ida Wyatt, inherited the said land at the time of the death of their said father which occurred more than twenty-five years ago, and these respondents pray the Court to have assigned to them, the said Sipp Wyatt and C.G. Wyatt, that portion of said land on which they have

erected their said improvements and on which they are now living, and make such orders and decrees as may be necessary to give them the benefit of their said improvements.
