





INTERROGATORIES TO THE PLAINTIFF

Comes now each of the following defendants, separately and severally, Huey Gene Bryant and George Purvey Thames, individually and, desiring the testimony of the plaintiff, pro- pounds to the plaintiff the following interrogatories, as is provided under Section 477, et seq., of Title 7 of the CODE OF ALABAMA of 1940, to wit:

1. State your correct name, age, residence address and business address.
2. State the name and address of your employer at the time of the occurrence made the basis of this suit and the type of work in which you were engaged.
3. Describe, to the best of your knowledge, each and every injury received by your minor child in the occurrence made the basis of this suit. (a) Describe and locate, to the best of your knowledge, each and every laceration or cut your said minor child sustained in said occurrence. (b) Describe and locate, to the best of your knowledge, each and every bruise, sprain, strain or contusion sustained by your said minor child in said occurrence. (c) Specify which, if any, of said injuries are permanent in nature, as best you know, and state the manner and degree in which said injury disables your said minor child. (d) Specify and describe in detail any and all other ailments resulting from said occurrence which have not already been enumerated by you, and state how and to what degree said condition manifests itself.
4. Give the name and address of each and every doctor who has attended your minor child for the injuries said minor child is alleged to have received in the occurrence made the basis of this suit. (a) Give the dates of treatment or examination of your said minor child by each and every said doctor, respectively. (b) What was the condition of your said minor child when said child was first attended by each of said doctors, separately and severally? (c) What was your said minor child's condition when said child was last attended by each of said doctors, separately and severally? (d) State the date on which your said minor child was last treated, examined or prescribed for by each of said doctors, separately and severally, and relate in substance what transpired at said time between you, your said minor child and each said doctor, and include the substance of each of said doctor's instructions to you or to your said minor child with reference to further treatment. (e) State the amount of the bill, separately and severally, of each respective doctor for the treatment rendered your said minor child for services performed for your said minor child, resulting from the occurrence made the basis of this suit. (f) State which of said doctors have been paid, and, if so, by whom. (g) State whether or not your said minor child had any form of medical insurance or other protection which took care of said doctors' bills. (h) Were you or your

minor child referred to any of the doctors heretofore mentioned by you in your answers to these interrogatories by the attorney or attorneys who represent you and, if so, state the name or names of such doctors. (i) Did any of the doctors heretofore mentioned by you refer you or your minor child to the attorney or attorneys who represent you or your said minor child and, if so, state which of said doctors did so.

5. State whether or not your minor child was hospitalized as a result of the occurrence made the basis of this suit. (a) If so, give the name and address of each said hospital where your said minor child was so confined. (b) Give the dates of your said minor child's confinement. (c) State the amount of each hospital bill incurred for your said minor child's confinement. (d) State whether or not any portion of said hospital bill was taken care of by hospitalization insurance or by any other form of protection. (e) State who paid or became obligated to pay said hospital bill or portion thereof.

6. State whether or not any X-rays were taken of your said minor child as a result of the occurrence made the basis of this suit. (a) Give the name and address of every radiologist who took said X-rays or who supervised their taking and when all said X-rays, respectively, were taken. (b) State each X-ray reading or your understanding of what each of the X-rays revealed. (c) Give the amount of each of said X-ray bills, and state by whom each was paid.

7. State whether or not special nurses, registered nurses or practical nurses attended your said minor child in and about the treatment of the injuries alleged to have been received by said minor child in the occurrence made the basis of this suit. (a) If so, give the name and address of each. (b) Give the dates your said minor child was attended by each of said nurses, separately and severally, and state whether they were special nurses, registered nurses or practical nurses. (c) Give the amount of each of said nurse's bill, separately and severally. (d) State who paid said bills and also whether said expenses were taken care of by any form of medical insurance or protection.

8. State whether or not you incurred any ambulance bills, drug expense or miscellaneous expense of any nature whatsoever not already enumerated as a result of the occurrence made the basis of this suit. (a) Describe each of said expenses, separately and severally, stating the amount of each. (b) By whom were each of said expenses paid?

9. State how long your said minor child was confined to bed at home, after, and as the result of, the occurrence made the basis of this suit, if said minor child was so confined, and state the dates of said confinement. (a) State how many days elapsed from the date of the said occurrence until your said minor child was able to be out of bed and up and about said child's home. (b) State how many days elapsed from the date of the occurrence made the basis of this suit until your said minor child was able to leave home and go to town or other places. (c) State the number of days which elapsed from the date of said occurrence before your said minor child was able to resume normal activities.

10. State whether or not, prior to the occurrence made the basis of this suit, your said minor child was ever at any time injured in any manner whatsoever to any extent. (a) If said minor child was injured prior to the occurrence made the basis of this suit in any manner, please describe in detail how said minor child was injured, giving the date of each such injury and the extent of said minor child's said injury. (b) Has your said minor child sustained any injuries of any nature whatsoever subsequently to the occurrence made the basis of this suit? (c) If so, describe the same fully and in detail. (d) Has your said



(a) If so, state the name and address of his employer and state in what capacity said child was employed. (b) State the child's average weekly earnings as of the time of said accident. (c) State the number of days and the dates thereof said child actually lost from his employment as a result of the injuries received by him from said accident. (d) State the total amount in wages, commissions or otherwise lost by said minor child as the result of the injuries received from said accident. (e) Who supported said child, financially, as of the time of the said accident? (f) With whom did said child live as of the time of said accident? (g) Who was paying for the maintenance and education of said child as of the time of said accident? (h) Was said minor child dependent upon his own resources for a livelihood at the time of said accident?
