#### CONTRACT AGREEMENT - READ CAREFULLY

I hereby acknowledge that I have filed an application with MANAGEMENT RECRUITERS OF MOBILE, INC., hereinafter referred to as MANAGEMENT RECRUITERS, to assist me in securing a position of employment and agree —

- 1. That, providing I accept a position secured (either directly or indirectly any time within two years from the date of my first referral to an employer) through the efforts of MANAGEMENT RECRUITERS I will pay to MANAGEMENT RECRUITERS a placement fee as follows:
  - (a) For permanent positions (those positions lasting 30 or more days), the placement fee is a percentage of the total compensation for the first year, as agreed to at the time of acceptance of the position.

- (b) For temporary positions (those positions lasting fewer than 30 days) the placement fee is twenty-five percent of all wages earned or the permanent placement fee for the same position, whichever is less.
