## SETTLEMENT AND PETITION

The undersigned, being the only parties in the above entitled cause, hereby petition the Court for approval of the following agreement and settlement, and agree and represent unto the Court as follows:

1. That the parties herein are subject to the provisions of the Workmen's Compensation Law of Alabama. That the said employee, age 22, residing at 940 Simmer Street, Prichard, Alabama, who can read and understand the English language, did on the 30th day of June, 1970, sustain an injury by accident while employed by said employer, which injury occurred at the employer's sawmill on Conception Street Road in Mobile, Alabama, and resulted in 10% permanent partial disability of the use of the right hand.

WHEREFORE, it is hereby agreed that the employee is entitled to and shall receive compensation for said injury from the employer for 27.2 weeks and payable as follows:

The sum of ONE THOUSAND ONE HUNDRED TWENTY-EIGHT (\$1,128.00) DOLLARS for 24 weeks, which has already been paid to the employee, the receipt of which is hereby acknowledged by the employee, and the balance of 3.2 additional weeks for a total of ONE HUNDRED FIFTY AND 40/100 (\$150.40) DOLLARS which is the commuted value in a lump sum settlement, and is the combined total of compensation commuted to be paid, all subject to the limitations of said act, and the employee hereby agrees to give proper receipts for each payment made hereunder.

The employee acknowledges that he has received to date all medical, surgical treatment and benefits given by said Act, and employer agrees to continue to furnish the same, if any be necessary, to the extent and in the manner required

said Act. The employee agrees to present himself for examination, or if physically unable to do so, to submit to examination by the physican or physicans designated by the employer, when requested.

This settlement contains the entire agreement between the parties hereto.
