BILL OF COMPLAINT


Plaintiff claims of the Defendant FIFTY-ONE DOLLARS (\$51.00) due by promissory note, made by Defendant on December 1, 1969, and payable February 1, 1970.

Plaintiff further avers that in and by the terms of said note, the Defendant agreed to pay interest at the rate of Six (6) percent per annum from December 1, 1969, and Plaintiff claims of the Defendant such interest in the amount of Seven Dollars (\$7.00).

or attempting to collect or secure said note, including a reasonable attorney's fee, and the Plaintiff further claims of the Defendant the further and additional sum of FIFTEEN DOLLARS (\$15.00) as such reasonable attorney's fee.
