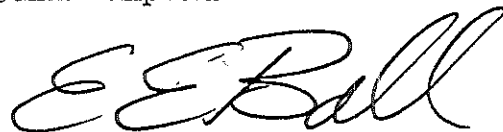
COMPLAINT
