M. on that day and immediately after the ceremony we returned to Summerdale. On the way to Summerdale the defendant informed me that he refused to live with me as husband, and carried me home. We have never lived together as man and wife.

He threatened me and told me that he did not love me and didn't intend to live with me. His actions towards me have been such that I believe my life is in danger of grave bodily harm and that he has been inhuman and unreasonable toward me. His conduct towards me has at all times been unreasonable and he has on several occasions since our marriage threatened my life and threatened to do harm to my person. There has been no cohabitation between us since our marriage.
