COUNT I.

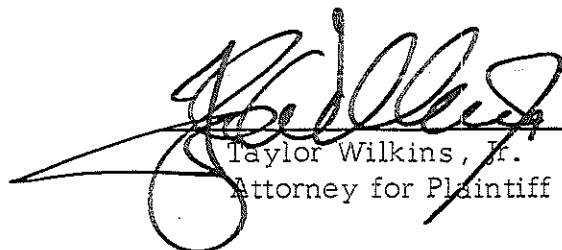
