

That upon the finalhearing of this cause Your Honor will grant unto Orator an absolute divorce from the said Annie Robinson, and will grant unto Orator the right to again contract marriage,

That if your Orator is mistaken in the relief prayed for,

Your Honor will grant unto him such other, fuyher, different, and general relief as he may in justice and equity be entitled, he will ever pray, etc.
