TO THE HONORABLE, JOHN D. LEIGH, JUDGE OF THE CIRCUIT
COURT, BALDWIN COUNTY, ALABAMA,- In Equity.

Your Orator, G. P. Pearce, respectfully represents
and shows unto your Honor as follows:

1. That he is a bona fide resident of Baldwin County,
Alabama, and have lived in said County for a period of
more than one year next preceeding the filing of this bill,
and that she is over the age of twenty-one years of age.

That Lula Pierce is a resident of Baldwin County,
Alabama and is over the age of twenty-one years of age.

2. That your Orator and the said Lula Pierce were
lawfully married in Baldwin County, Alabama, about two years
ago and lived together as man and wife until to-wit: Aug-
27th, 1920, at which time the said Lula Pierce committed
the act of adultery with an unknown man; your Orator did
not connive or condone the said act of adultery.

PRAYER FOR PROCESS.

The premises considered your Orator prays that the
said Lula Pierce be made party respondent to this bill of
complaint by the usual process of this Honorable Court and
that she be required to demur, plead to or answer the same
within the time allowed by law or that the same be forever
confessed.

PRAYER FOR RELIEF.

That upon the final hearing of this cause your
Honor will grant unto Orator an absolute divorce from the
said Lula Pierce.

That if your Orator is mistaken in the relief pray
ed then your Honor will grant unto him such other, further,
different and general relief as he may in justice and eq-
uity be entitled, he will ever pray, etc.

FOOT NOTE:

The respondent, Lula Pierce, is required to answer each and every allegation of the foregoing bill of complaint from paragraph 1 to 2, both inclusive, but not under oath, answer under oath being hereby expressly waived.
