
COUNT III

COUNT IV



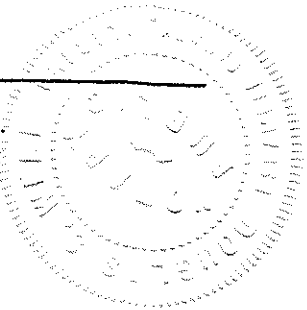
