### COUNT 1

The Plaintiff claims of the Defendant the sum of Four Hundred Fifteen Dollars and Thirty-five cents (\$415.35) due from A.B. McDILL, the defendant, to H. F. FINDLEY, the plaintiff by account on the 26th day of May, 1953, which said sum of money, together with the interest thereon is still unpaid.

## COUNT II

The Plaintiff claims of the Defendant the sum of Four Hundred Fifteen Dollars and Thirty-five cents (\$415.35) due from the defendant, A. B. McDILL to the plaintiff, H. F. FINDLEY on an account stated between the Plaintiff and Defendant on the 26th day of May, 1953, which said sum of money, together with the interest thereon is still due and unpaid.
