

TO THE HONORABLE W. R. STUART, JUDGE OF PROBATE OF BALDWIN COUNTY,
ALABAMA:

Your petitioner, the County of Baldwin, in the State of Alabama, by R. J. Robertson, its agent, as chairman of the County Commission, duly elected, qualified and authorized hereto, respectfully shows unto your Honor as follows:

FIRST: That under the laws of the State of Alabama, your petitioner, Baldwin County, Alabama, is charged with the duty of providing rights of way for roads constructed within said county; that the said Baldwin County, acting through and by the State Highway Department, has surveyed and adopted and proposes to construct a public road over and across the lands hereinafter described and the said lands are needed and desired by the County for public purposes, namely, as a right of way for a public road; that it is necessary and proper and to the best interest of said county, and the State Highway Department has approved, that the county acquire for a right of way for public road purposes the lands described as follows, to-wit:

Parcel 1, owned by Rose Worcester and Olive Worcester:
As shown by the right of way map of Projects No. F. I. 346 (1) and (F)S-635 (1) as recorded in the office of the Judge of Probate of Baldwin County:

Beginning at approximate Station 17⁷/50 where the center line of the line that connects the center line of Project No. F. I. 346 (1) with the center line of Federal Project No. S-635 (1) becomes 85 feet southerly of the present North right of way line of U. S. Highway Nos. 31 and 90 as measured at right angles to said center line; thence north-easterly along a curve to the left (concave north-easterly) having a radius of 1432.69 feet, a distance of 171.7 feet; thence North 62° 12' East, a distance of 53.3 to the point of ending at Station 19⁷/75, the east property line;

Said strip of land being 85 feet wide on the north side of the center line of the line that connects the center lines of said Projects; lying in the Northeast quarter of Southeast quarter of Section 25, Township 4 South, Range 1 East, and containing 0.15 acres in addition to that part occupied by the present right of way of U. S. Highway Nos. 31 and 90;

Parcel 2: As shown by right of way map of Federal Project No. S-635 (1), as recorded in the office of the Judge of Probate of Baldwin County:

Beginning at Station 60⁷/76 where the center line of Federal Project No. S-635 (1) intersects the North property line; thence South 7° 25' East, a distance of 461 feet to the point of ending at Station 65⁷/37 where said center line intersects the South property line;

Said strip of land being 90 feet wide on each side of the center line of said Project; lying in the East half of Northwest quarter of Section 31, Township 4 South, Range 2 East, and containing 1.90 acres, more or less;

Parcel 3: As shown by the right of way map of Federal Project No. S-635 (1), as recorded in the office of the Judge of Probate of Baldwin County;

Beginning at Station 59⁷/46 where the center line of Federal Project No. S-635 (1) intersects the North property line; thence South 7° 23' East, a distance of 128 feet to the point of ending at Station 60⁷/76 where said center line intersects the South property line;

Said strip of land being 110 feet wide on the East side and 90 feet wide on the West side of the center line of said project; lying in the Northeast quarter of Northwest quarter of Section 31, Township 4 South, Range 2 East, and containing 0.59 acres, more or less;

SECOND: That Rose Worcester and Olive Worcester, who are each over the age of twenty-one years, and whose post office address and place of residence are as follows: Rose Worcester, Fairhope, Alabama, Clive Worcester, 8128 Cookacre Avenue, Compton, California, are the owners of and are in the peaceable possession and control of the lands described as Parcel 1; that Maude L. Manci, L. T. Rhodes, Jr., J. F. B. Lowrey, Eloise Martin, Clara R. Bolon, and L. T. Rhodes, Jr., and Maude L. Manci, as administrators of the estate of J. S. Lowrey, deceased, who are each over the age of twenty one years, and whose places of residence and post office addresses are as follows:

Maude L. Manci, Bay Minette, Alabama; L. T. Rhodes, Jr., Bay Minette, Alabama, Clara R. Bolon, Bay Minette, Alabama, J. F. B. Lowrey, Burnt Corn, Alabama; Eloise Martin, Dothan, Alabama, are the owners of and are in the peaceable possession and control of the lands described as parcels 2 and 3;


THIRD: That the said Baldwin County further alleges, and the State Highway Department approves, that it is necessary and

proper and to the interest of the County of Baldwin that this County have and own the said lands for the purpose of a right of way for a road and this petitioner desires to have said lands condemned for and as a road for the use of the said county as a right of way for a public road.

Premises Considered, your petitioner prays this Honorable Court will make an order appointing a day for the hearing of this petition; that due and legal notice of the same be given to the said Rose Worcester, Olive Worcester, Maude L. Manci, L. T. Rhodes, Jr., J. F. B. Lowrey, Eloise Martin, Clara R. Bolon, and L. T. Rhodes, Jr. and Maude L. Manci as administrators of the estate of J. S. Lowrey, deceased, and that such other, further and general orders and decrees be made in the premises as may be necessary and proper for the acquirement by the petitioner of the property herein described for the purposes herein stated.




