- COUNT I -


The Plaintiff claims of the Defendant One Thousand Two Hundred Dollars (\$1,200.00) due by Promissory Waive Note made by him on, to-wit, August 17, 1953, and payable on, to-wit, September 21, 1953, with interest at the rate of eight per cent (8%) per annum from and after March 19, 1954.

The Plaintiff avers that in and by the terms of the said note the Defendant waived all rights to exemption under the Constitution and Laws of Alabama as to personal property and of this waiver the Plaintiff now claims the benefit.

The Plaintiff further avers that in and by the terms of said note, the Defendant agreed to pay all costs of collecting or

securing, or attempting to collect or secure this note, including a reasonable attorney's fee, and the Plaintiff further claims of the Defendant the further and additional sum of Two Hundred Dollars (\$200.00) as such reasonable attorney's fee.
