COUNT ONE:

The Plaintiff claims of the Defendant One Thousand Dollars (\$1000.00) as damages for that on heretofore, to-wit, the 27th day of February, 1954, at 8:00 o'clock a.m., the Defendant so negligently operated his motor vehicle on U.S. Highway #90 at the Intersection thereof with the Loxley-Daphne farm-to-market road, a public highway in Baldwin County, Alabama, as to cause or allow said motor vehicle to collide with the motor vehicle of the Plaintiff which was then and there being operated by Pearl D.
