TO ANY SHERIFF OF THE SAID STATE, GREETING:

WHEREAS, on the 24th day of June, 1955, the Baldwin County Bank, a corporation, filed a complaint in the Circuit Court of Baldwin County, Alabama, claiming of Haggard R. Williams, also known as H. R. Williams, the sum of One Hundred Dollars (\$100), interest and attorney's fees, on which a summons has issued and the said Baldwin County Bank, by its agent, having made affidavit that the First National Bank, Bay Minette, Alabama, is supposed to be indebted to or have in its possession or under its control goods, effects or things in action belonging to the said defendant, and that it believes the process of garnishment against the said First National Bank is necessary to obtain satisfaction of said claim.

Williams, in the sum of Two Hundred Fifty Dollars (\$250), for the payment of which well and truly to be made the principal binds itself, its successors and assigns, and the sureties bind themselves, their heirs, executors and administrators, jointly and severally, by these presents.

Sealed with our seals and dated this 24th day of June, 1955.

The condition of the above obligation is such that, Whereas, the above bound Baldwin County Bank, a corporation, has brought a suit now pending against the said Haggard R. Williams in the Circuit Court of Baldwin County, Alabama, to recover of the said Haggard R. Williams the sum of One Hundred Dollars (\$100), interest and attorney's fees, and has this day prayed that a writ of garnishment issue to the First National Bank, Bay Minette, Alabama, to answer what it is indebted to or what effects of the said defendant it has in its possession or under its control, and the said plaintiff, by its agent, having made oath and entered into this bond as required by law, has obtained said writ of garnishment returnable at the next term of the said court.

Now, if the said plaintiff shall prosecute its said suit to effect and pay the defendant all such damages as he may sustain by the wrongful or vexatious suing out of said garnishment, then this obligation to be void, otherwise to remain in full force and effect.
