This indenture made this day in duplicate by and between, Mrs. Frank Schwartz, party of the first part and Martin Sommer, Party of the second part, Witnesseth:

That the party of the first part hereby agrees to sell to the party of the second part the following described lands on the terms and conditions hereinafter set forth:

The Northwest Quarter of the Southwest Quarter of Section 20, Township 7 South, Range 6 East and the West one-half of the Southwest Quarter of the southwest quarter of Section 20, Township 7 South, Range 6 East, Baldwin County, Alabama containing 60 acres more or less and improvements thereon.

This contract subject to that certain lease rental agreement now in effect between party of the first part and Joe Krieger.

Party of the first part hereby acknowledges receipt of One Hundred and fifty dollars and no cents as down payment on the purchase price of the aforesaid property. Such payment being made herewith by the party of the second part.

Party of the second part to rent the dwelling on the premises for a rent of no less than \$50.00 per month. All rents collected by the party of the second part to be used first for the payment of taxes, insurance, and maintenance and the balance of the rental payments recieved to be turned over to the party of the first part to apply on the down payment.

Both parties to this instrument hereby agree that on or about the first of 1956 a contract for the purchase of said property will be entered into by both parties at a purchase price of \$15,000.00 on terms to be spread over a period of ten years with interest on the unpaid balance at the rate of 3% per annum.

In the event of a failure by the party of the second part to enter into a purchase and sale agreement on the first of the year the party of the first part shall retain all monies recieved by her to compensate for rent and damages recieved by her and the party of the second party shall not be held liable for further payment.

It is hereby understood and agreed by both parties hereto that the following articles are included in the agreed purchase price: One butane cook stove, One butane hot water heater, two butane space heaters and one single bed.

The Northwest Quarter (NW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$), and the West Half (W $\frac{1}{2}$) of the Southwest quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section twenty (20), Township seven (7) South, Range six (6) East, containing 60 acres, more or less.

Together with, all and singular, the rights, benefits, privileges, improvements, tenements, hereditaments and appurtenances unto the same belonging or in any wise appertaining.

There is hereby reserved to the Grantor, for her lifetime, and undivided one-half $(\frac{1}{2})$ interest in and to all rents and royalties derived from the leasing or sale of any oil, gas or minerals, provided, however, that the Grantee, his heirs or assigns, shall have the full and exclusive right to lease, rent or sell such mineral interests, and further providing that this reservation terminates on the death of the Grantor.
