The Plaintiff claims of the Defendant Seven Thousand Dollars (\$7,000.00) as damages, for that heretofore, on to-wit, May 17, 1956 the Plaintiff was lawfully operating an automobile along a public road, or highway, near the City of Fairhope, County of Baldwin, State of Alabama, to-wit, commonly referred to as the Grand Hotel Farm Road, and the State of Alabama Public road running between U. S. Highway 98 and Greeno Road in Baldwin County, Alabama, and that then and there the Defendant's servant, agent or employee, while acting within the line and scope of his employment, negligently allowed a water sprinkler to throw water in and on the said road so as to cause the road to become wet and slippery, and as a proximate consequence thereof, Plaintiff's automobile did become damaged and demolished, or greatly damaged or rendered less valuable, and the Plaintiff received severe personal injuries in this, to-wit, she was bruised and lacerated about the leg, face and body; she was made sick, sore and lame; she received multiple

lacerations, contusions and abrasions about her face and body; she was caused to expend considerable sums for medical treatment, hospital care, and medicines in and about the treatment of her injuries; her clothing and personal effects were damaged and injured, for all of which she claims damages as aforesaid.
