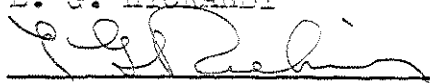
COUNT II.

COUNT III.

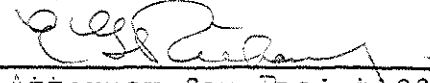

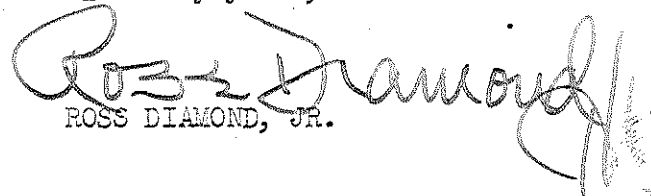
