The Complainant claims of the Respondents the sum of TWO HUNDRED SEVENTY NINE AND 47/100 DOLLARS (\$279.47) due from them by account on the 14th day of July, 1938 which sum of money with interest thereon is still unpaid.

TWO: The Complainant claims of the Respondents Two Hundred Seventy nine and 47/100 Dollars (\$279.47) due from them upon account stated between the Complainant and the Respondents on the 14th day of July, 1938 which sum of money with interest thereon is still unpaid.

THREE: The Complainant claims of the Respondent Two Hundred Seventy nine and 47/100 Dollars (\$279.47) due from them for merchandise, goods and chattels sold by the Complainant to the Respondents on or about July 14th, 1938, which sum of money with interest thereon is still unpaid.

FOUR: Complainant further avers that the construction of the house into which said building material was wrought is located upon the land owned by the Respondents Anne Wilkes and/or Mary Peterson and that the building was constructed by Anne Wilkes' husband Willie Wilkes, the joint Respondent, and that the order for part of the materials was delivered to the Complainant by the Respondent Anne Wilkes while the building was under construction and that she was informed by the Complainant of the terms of payment for the said material and that the material was furnished at her request as well as at the request of the co-respondent Willie Wilkes and that the Complainant did agree to sell to the Respondents certain building materials upon the assurance from the Respondents that the purchase price on the same would be paid to the Complainant, and, prior to the delivery of the materials the Respondents Anne Wilkes and Mary Peterson had verbal notice of the same and the materials then were delivered at the request of the joint respondents; that the total of the material delivered was Five Hundred Eleven and 52/100 Dollars (\$511.52) and that payments were made totaling Two Hundred Thirty-two and 05/100 Dollars (\$232.05) leaving the balance now due for which this materialmen's lien is claimed of Two Hundred Seventy nine and 47/100 Dollars (\$279.47) which said amount is still due and unpaid.

Complainant further avers that on August 9th, 1938 he filed in the Probate Court of Baldwin County, Alabama, where the Respondents reside and where the said Respondents! land on which the said improvements were erected is located, Complainant's verified statement of his account with the Respondents which is in words and figures as follows:
