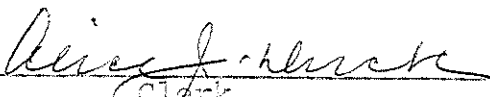

COUNT II:

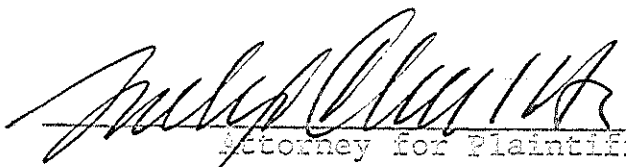

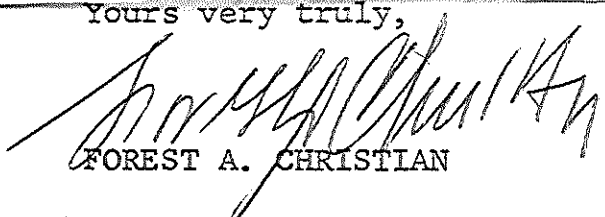
