KNOW ALL MEN BY THESE PRESENTS:- That we, Robert E. Godsey, as Principal, and the undersigned, as Sureties, are held and firmly bound unto the City of Foley, a Municipal Corporation, in the sum of \$ One Thousand Five Hundred for the payment of which, well and truly to be made, we bind ourselves, our heirs, executors, and administrators, jointly and severally, firmly by these presents.

Witness our hands and seals on this the 9th day of March, 1957.

The condition of the above obligation is such, That, Whereas, the above bounden Robert E. Godsey was on the 9th day of March, 1957, convicted in the Municipal Court of the City of Foley, Baldwin County, Alabama, of the offense of Violation of Ordinance #101 and by the judgment of said Court sentenced to a fine of one hundred Dollars in each of ten cases and Costs of Court.

And, Whereas, the said Robert E. Godsey has this day prayed an appeal from said judgment to the Circuit Court of this County:

Now, if the said Robert E. Godsey shall appear at the next term of the Circuit Court and from term to Term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void, otherwise to remain in full force and effect.
