COUNT ONE

The plaintiff claims of the defendants the sum of SIX HUN-DRED (\$600.00) DOLLARS, as damages, for that, heretofore, on, to-wit: the 2nd day of January, 1957, at about 9:00 o'clock, A. M., at the intersection of Sevent's Street and Moog Avenue, Public Highways, in the City of Bay Minette, Baldwin County, Alabama, the defendant, MARION ERNIE FLEMING, who was then and there an agent, servant, or employee of the defendant, CITY OF BAY MINETTE, A MUNICIPAL CORPORATION, acting within the line and scope of his employment as such, so negligently operated an automobile truck, belonging to the defendant, CITY OF BAY MINETTE, which he was then and there driving, as to cause plaintiff's automobile which was then and there being driven by plaintiff's wife, BETTY RUTH KNOWLES, to run into, upon or against said automobile truck, and as a proximate result of the negligence of the said MARION ERNIE FLEMING, as aforesaid, plaintiff's automobile was demolished, damaged beyond repair, and rendered a total loss. And plaintiff avers that his said damages to his said automobile were proximately caused by the negligence of the defendant, MARION ERNIE FLEMING, an agent, servant or employee of the defendant, CITY OF BAY MINETTE, A MUNICIPAL CORPORATION, then and there in charge of said automobile truck for the City of Bay Minette and acting within the line and scope of his employment as such, in that the said MARION ERNIE FLEMING negligently operated said automobile truck at the time and place of the said collision.

And plaintiff alleges that a statement of said claim was filed with the defendant, CITY OF BAY MINETTE, A MUNICIPAL CORPORATION, within six (6) months after January 2, 1957, and that said City of Bay Minette, a Municipal Corporation, has failed or refused to pay the same;
