COUNT TWO:

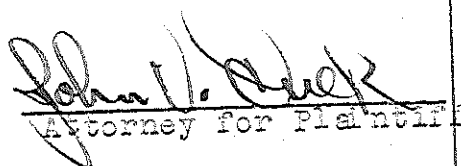
