COUNT I

The Plaintiff claims of the Defendant ONE HUNDRED AND TWO DOLLARS (\$102.00) due by promissory note made by him on, to-wit, the 29th day of September, 1956, and payable in eleven installments of TWENTY DOLLARS (\$20.00), payable on the 28th day of each consecutive month, beginning October 29th, 1956, and the balance of TWENTY-ONE DOLLARS (\$21.00) payable on the 29th day of August, 1957; and the Plaintiff avers that the Defendant defaulted in the payment due on the 29th day of June, 1957, and the Plaintiff under the terms of said note declared the entire unpaid balance due and payable;

And the Plaintiff avers that in said note and as a part of the consideration thereof, the Defendant has expressly waived his rights to claim personal property as exempt to him under the Constitution and laws of the State of Alabama and agreed to pay an attorneys fee for the collection thereof and the Plaintiff hereby claims the further sum of TWENTY-FIVE DOLLARS (\$25.00) as such attorneys fee.
