COUNT ONE

Plaintiff claims of the Defendant the sum of, to-wit, FOUR-HUNDRED, NINETY-NINE and THIRTY-FIVE ONE-HUNDREDTHS (\$499.35) DOLLARS, damages, for the breach of a written agreement entered into by the Defendant on, to-wit, January 12, 1957, by which he promised to pay to J. E. Still Motor Company the sum of to-wit, \$47.60 each month, commencing on, to-wit, March 1, 1957; and continuing on the 1st day of each month thereafter until the sum of, towit, \$1142.40 had been paid for the purchase of an automobile; said written instrument provided that in the event of a default in said payments, the entire amount would then become due, and the Plaintiff could seize said automobile and sell same at a public or private sale, with or without advertisement, with or without notice to the Defendant, and apply the proceeds of said sale to the remainder due under the said written instrument, and in the event of a deficiency the Defendant agreed to pay the amount of the deficiency. Plaintiff avers that said written instrument, together with all rights thereunder, was assigned to it by the said J. E. Still Motor Company, before default in said written instrument, for which a valuable consideration has been paid.
